

Transferring to Center Grove from another High School?

IHSAA Athletic Transfer Process

- A parent signature form will need to be signed and witnessed by a Center Grove Athletic Administrator prior to returning the transfer report to the previous high school.
- The Center Grove Athletic Department will need the following information when initiating the Transfer Report. This information should be completed on the accompanying forms and brought to the Center Grove Athletic Office by a parent of the student.
- This form will be e-mailed to the previous school for additional information. That information will detail eligibility and participation at the previous school. It will also provide a recommendation from the previous Athletic Administrator for the level of involvement at Center Grove. That recommendation would be Full Eligibility, Limited Eligibility (JV or Frosh) or No Eligibility as outlined by the IHSAA by-laws regarding the transfer process.
- Once the form has been returned via e-mail by the previous school, a recommendation by the Center Grove Athletic Administration will be added. That recommendation would be Full Eligibility, Limited Eligibility (JV or Frosh) or No Eligibility as outlined by the IHSAA by-laws regarding the transfer process.
- The form will then be e-mailed to the IHSAA for a final decision.

Rule 19-5 Student transferred with corresponding change of residence to new district or territory with the Student's custodial Parents/Guardians?

Rule 19-6.1 Student transfers without a corresponding change of residence by Parents/Guardians. A Student who qualifies under the following criteria may have immediate eligibility (one or more of the criteria may be checked).

___ A. Student is a ward of the court.

___ B. Student transfers to reside with a parent. Has student previously moved between separated or divorced since entering high school? ___ *yes* ___ *no* If yes, when: _____

___ C. Student is an orphan.

___ D. Student's former school is closed.

___ E. Student's former school is not accredited by the state accrediting agency.

___ F. Student is transferring pursuant to a school board mandate for redistricting.

___ G. Student attended, in error, a wrong school.

___ H. Student is transferring from a correctional school.

___ I. Student is emancipated and has established a bona fide residence in new district.

___ J. Student did not participate in any interschool contest as a representative of another school during the preceding 365 days, or (ii) did not compete in club sports in a sport during the preceding 365 days, when the Student's former school did not offer a program in that sport.

___ K. Student is entering an IHSAA member school from a non-member school, to reside with a Parent/Guardian with whom the student previously resided, in the public school district or private school territory serving the residence of the Parent/Guardian.

___ L. Student is transferring to a member boarding school with a corresponding move from the residence of the Student's Parents or the Student is transferring from a member boarding school with a corresponding move to the residence of the Parents.
